




# The Next UAE: Engineering a Premium Investment Frontier | 2026 - 2035

# The UAE is systematically creating a new asset class, driven by a non-negotiable national commitment to sustainability.



- **Binding Policy:** Sustainability is no longer optional; it is a mandatory pillar of national strategy, enforced by new regulations effective 2025.
- **Massive Capital Deployment:** Over AED 200 billion is actively being invested in green infrastructure, creating tangible, large-scale assets.
- **Clear Financial Upside:** This strategic shift is designed to produce a distinct asset class, projected to command significant price premiums of 8-12% for ESG-compliant properties.
- **New Capital Inflows:** New financial frameworks are being established to channel institutional capital directly into these sustainable projects.



A human-centric city of the future, leveraging legacy infrastructure for innovation and sustainability.


**Al Marjan Island (RAK):**



## Projected Price Premium: ESG-Compliant Assets




## The Premium Asset Class
